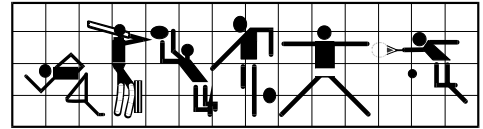

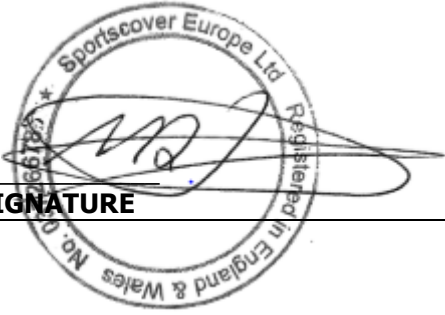
#### **COMMUNICABLE DISEASE EXCLUSION**

Communicable Disease means any disease capable of being transmitted from an infected person or species to a susceptible host, either directly or indirectly.

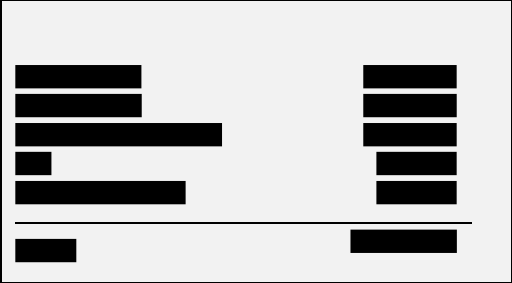
